- Knowledge of technical terms: Students should be familiar with technical terms and key concepts related to their field of study.
- Communication skills: Students should be able to communicate effectively in English in an academic context, including participating in group discussions and making oral presentations.
- Motivation: Students should be motivated and committed to learning English, willing to work hard to improve their language ability.

Week 1: Introduction to Academic English & Research Writing

- Course overview, features of academic English (formality, clarity, objectivity).

Week 2: Research Problem & Objectives

- Writing research questions and hypotheses.

Week 3: Literature Review (Part I)

- Purpose and structure. Summarizing sources.

Week 4: Literature Review (Part II)

- Paraphrasing, synthesizing multiple studies, avoiding plagiarism.

Week 5: Methodology Section

- Describing research design, sampling, data collection, instruments.

Week 6: Writing the Results Section

- Presenting data, charts, and statistical outcomes.

Week 7: Writing the Discussion Section

- Interpreting results, linking to theory and literature.

Week 8: Writing the Conclusion & Recommendations

- Summarizing contributions, limitations, and future research.

Week 9: Abstracts & Titles

- Crafting effective abstracts and selecting suitable titles.

Week 10: Referencing & Citations

- APA/MLA styles, in-text citation, reference list.

Week 11: Cohesion & Coherence in Academic Writing

- Transitions, connectors, maintaining logical flow.

Week 12: Editing & Proofreading

- Grammar, vocabulary, and style refinement.

Week 13: Oral Defense Preparation

- Presentation structure, signposting language, handling Q&A.

Week 14: Final Presentations & Mock Thesis Defense

- Students simulate defense with feedback.
